IFFM is produced by Mind Blowing Films, a Melbourne-based distributor of Indian cinema across Australia and New Zealand. It is an important fixture in the local arts calendar: permitting a local audience to engage with some of Bollywood's best. The festival also travels to Sydney, and has previously travelled to Adelaide, Perth, and Auckland. The festival presents a diverse array of film and events with cinema, both indie and Bollywood, curated from across both India and the diaspora, and strives to foster an inclusive cultural collaboration.
